

### SPOTLIGHT ON THE UK GROUND INVESTIGATION INDUSTRY




The Association of Geotechnical and Geo-environmental Specialists (AGS) and the British Drilling Association (BDA) agreed in 2016 to set up a joint initiative to shine a 'Spotlight' on the UK Ground Investigation industry. 
## **RESULTS FROM THE SURVEY**


#### **EXPERIENCE AND BEST PRACTICE FROM OTHER COUNTRIES**

Question 16 of the survey asked participants the following: "Do you have experience of applying non-UK technical standards?"









Question 22e of the survey asked to what extent participants agreed with the following statement: "The UK GI industry would benefit from adopting best practice from other countries."

- In total, 23% agreed with this statement and 21% disagreed. A majority of respondents, 56% remained neutral.
- Statistical analysis revealed that Members of the British Drilling Association were more likely to disagree to any extent.

A further question (23) was asked to clarify which practices from other countries respondents thought might be adopted. A total of 62 text responses were submitted. Among the suggestions were:

- 7 In situ tests
- 5 Rotary boring
- 5 Health and safety
- 5 Practices in Australia

- 3 CPT testing
- 2 US EPA
- 2 Alternative to Cable Percussion Boring
